Fighting for Human Rights at the Heart of EU Housing Policy

The EU is developing its first-ever Affordable Housing Plan, a historic shift after a history of staying out of housing policy. Ribera Carbó submitted recommendations and spoke at the European Parliament's Greens/EFA Housing Summit, presenting evidence of how financialisation has driven the crisis.
